17 COME NOW the Parties by and through their respective counsel of record, and hereby 18 stipulate and agree, and ask for the court's approval, to extend the deadline to file the Joint Status 19 Report ordered by Magistrate Judge Hoffman on August 2, 2019 for AN ADDITIONAL two weeks, 20 21 from August 30, 2019 through and including September 13, 2019. The reason for this request is 22 that the parties have continued to be tied up with other matters, especially including counsel for 23 Plaintiff being focused on preparation for trial that was scheduled with Judge Dorsey for August 27-24 30 and only settled on the eve of trial on August 26. As a result of that Plaintiff's counsel is now 25 required to prepare for and travel to Washington State for deposition in a case on which he was just 26 27 admitted pro hac vice in the Central District of California.
