**STIPULATION AND ORDER

(First Request)

STIPULATION

16 Plaintiff Jazmin Arellano ("Arellano") and Defendant Giorgio Armani Corporation
 17 ("GAC"), by and through their respective counsel of record, stipulate and agree as follows:

- 18 1) On December 18, 2014, Arellano filed a Complaint in the above-entitled action.
- 19 2) On April 9, 2015, Arellano filed a First Amended Complaint.
- 20 3) On April 13, 2015, Arellano served GAC with the Summons and First Amended
 21 Complaint. Accordingly, GAC's deadline to respond to the First Amended Complaint is May 4,
 22 2015.
