AMENDED ORDER

Before the Court for consideration is Defendant's Motion for Clarification Regarding the Court's Minute Order of May 3, 2017 (#78).

The Court amends its Minute Order of May 3, 2017 (#77) as follows:

1. Defendant's operative Summary Judgment Motion is ECF No. 55;
2. Plaintiff's operative Response to Defendant's Summary Judgment Motion is ECF No. 61;
3. Defendant shall file its Reply to ECF No. 61 fourteen (14) days from the date of this Order;
4. Defendant's Motion to Strike ECF No. 61 (#64), is therefore **denied** as this Court construes this document as Plaintiff's operative Response to Defendant's Motion for Summary Judgment;
5. Defendant's Motion to Strike ECF No. 63, Plaintiff's 1st Amended Response to Defendant's Motion for Summary Judgment (#69) is **granted**;
6. Plaintiff's operative Summary Judgment Motion is ECF No. 62;
7. The Court grants Defendant twenty-one (21) days from the date of this Order to file its Response to ECF No. 62;

1 8. Plaintiff's Reply to Defendant's Response is due within fourteen (14) days of the
2 filing of Defendant's Response; and

3 9. Defendant's Motion to Strike ECF No. 62 (#68), is **denied**.

4 The Court liberally construes pro se litigant filings, however, the Court reiterates its admonition that
5 no further amended filings are permitted by either party in this case.

7 Accordingly, **IT IS THEREFORE ORDERED** that:

8 1. Defendant's Motion to Strike Plaintiff's Amended Response to Defendant's Motion
9 for Summary Judgment (#64) is **denied**;

10 2. Defendant's Motion to Strike ECF No. 62 (#68), is **denied**;

11 3. Defendant's Motion to Strike Plaintiff's 1st Amended Response to #55 Motion for
12 Summary Judgment (#69) is **granted**;

13 **IT IS FURTHER ORDERED** that Defendant shall file its Reply to ECF No. 61 within (14)
14 days of the date of this Order;

15 **IT IS FURTHER ORDERED** that Defendant shall file its Response to ECF No. 62 within
16 twenty-one (21) days of the date of this Order;

17 **IT IS FURTHER ORDERED** that Plaintiff shall file its Reply to Defendant's Response to
18 ECF No. 62 within fourteen (14) days of the date of the filing of Defendant's Response.
