**ORDER GRANTING
STIPULATION FOR DISMISSAL WITH

23 Currently before the Court is the stipulation for dismissal with prejudice filed by plaintiffs
24 Lynelle Hernandez and Jose Hernandez and defendant Navient Solutions, Inc. Navient Solutions,
25 Inc. f/k/a Sallie Mae, Inc., erroneously sued as "Navient Solutions, Inc., a foreign corporation,
