The parties stipulate and request that the Court enter an order
 staying the following deadlines pending the resolution of defendant DePuy
 Orthopaedics, Inc.'s ("DePuy") Motion to Dismiss (#19):

1. The deadline for the remaining defendants to respond to Plaintiff's Complaint (#1); and
2. All deadlines and requirements imposed by Fed. R. Civ. P. 26(f) and LR 26-1, including but not limited to filing a joint discovery plan and scheduling order.

1 This is the first continuance sought in connection with these
2 deadlines. To potentially reduce the costs associated with this litigation,
3 the parties do not wish to engage in additional pleadings, motion practice,
4 or discovery until the Court has ruled on the statute of limitations issue
5 presented in DePuy's motion.

6 The parties further stipulate that nothing in this stipulation
7 waives any defenses or potential defenses that could be raised. If the Court
8 denies DePuy's motion to dismiss, the parties agree that the remaining
9 defendants who have been served at the time that the Court issues its
10 ruling shall have 21 days after the Court issues its ruling on the motion to
11 dismiss to file their responses to Plaintiff's Complaint. The parties will
12 then have 30 days thereafter to file their joint discovery plan and proposed
13 scheduling order pursuant to Fed. R. Civ. P. 26(f) and LR 26-1.


