(First Request)

2 1. On February 19, 2015, Plaintiffs served John Fowler (the "First Served
3 Defendant") with a copy of the Summons and Complaint.

4 2. In accordance with Fed. R. Civ. P. 4(a)(1)(A)(i), the First Served Defendant has
5 up to and including March 12, 2015, to file a response to the Complaint.

6 3. However, undersigned defendants' counsel will serve as local counsel for all
7 twenty-six defendants, including the First Served Defendant.

8 4. To enable counsel to coordinate the defense of all twenty-six defendants, avoid
9 the time and expense of filing numerous separate responses to the Complaint, and to provide for
10 acceptance of service for any defendants not yet served, and defendants agreeing not to contest
11 the sufficiency of process or the sufficiency of service of process, the parties stipulate that all of
12 the defendants, regardless of the date of service, shall have up to and including April 13, 2015, to
13 file a response to the Complaint.
