8 7. Due to counsel for Plaintiff Fisher having recently been out of state taking
9 depositions in a separate case and Plaintiff's counsel being out of the office sick, the parties
10 hereto hereby agree to extend Plaintiff Fisher's Reply in Support of the Motion to be due on or
11 before January 16, 2017.

12 8. The parties thus agree that good cause exists for the stipulated extension pursuant
13 to LR IA 6-1.
