1 WHEREFORE, on March 9, 2016, Green Tree Servicing LLC, now known as Ditech
2 Financial LLC (“Green Tree”) filed its Motion for Summary Judgment (Docket No. 40);

3 WHEREFORE, on April 4, 2016, Hometown Ovation HOA (“HOA”) filed its Response to
4 Green Tree’s Motion for Summary Judgment (Docket No. 48);

5 WHEREFORE, Green Tree’s Reply to the HOA’s Response to Green Tree’s Motion for
6 Summary Judgment is currently due on or before April 18, 2016;

7 WHEREFORE, on April 5, 2016, Plaintiff Saticoy Bay LLC Series 3012 Silver Canyon
8 (“Plaintiff”) and Green Tree filed their Stipulation to Extend Time to File Plaintiff’s Response to
9 Green Tree’s Motion for Summary Judgment and Green Tree’s Reply to Plaintiff’s Response
10 (Docket No. 51);

11 WHEREFORE, on April 6, 2016, the Court granted Plaintiff’s and Green Tree’s request for
12 extension of time to file Plaintiff’s Response to Green Tree’s Motion for Summary Judgment and
13 Green Tree’s Reply to Plaintiff’s Response (Docket No. 52);

14 WHEREFORE, Green Tree’s Reply to Plaintiff’s Response to Green Tree’s Motion for
15 Summary Judgment is currently due on or before May 6, 2016;

16 WHEREFORE, the parties stipulate as follows:

17 IT IS HEREBY STIPULATED AND AGREED between Green Tree and the HOA, by and
18 through their undersigned attorneys, that Green Tree shall have up to and including Friday, May 6,
19 2016 to file its Reply to the HOA’s Response to Green Tree’s Motion for Summary Judgment.

20 Rather than file discrete briefs addressing individual issues, Green Tree intends to present to
21 the Court a joint Reply to both Plaintiff’s and the HOA’s Responses. An extension for Green Tree
22 to file a joint Reply brief will allow Green Tree to address the myriad substantive issues in the
23 HOA’s Response and those anticipated in Plaintiff’s Response. This extension will also advance
24 judicial economy because one reply brief is considerably more manageable than two largely-
25 duplicative reply briefs.
