1 Young–Nevada LLC, Mark Rose, Joseph Kupiec, John Pinjuv, and The Nevada Commercial
2 Group (“Defendants”), through their counsel of record, hereby stipulate and request that the Court
3 continue the hearing on Plaintiff’s Motion to Reconsider the Protective Order’s “Highly
4 Confidential” Provisions and Consolidate Selected Depositions (ECF No. 123) (“Motion
5 Regarding the Protective Order and Depositions”) and Plaintiff’s Motion to Substitute Newmark
6 Group Inc. for BGC Partners Inc. as Plaintiff (ECF No. 132) (“Motion to Substitute”) (together,
7 the “Motions”) as follows:

10 **STIPULATION**

11 1. Plaintiffs filed their Motion Regarding the Protective Order and Depositions on
12 February 14, 2018.

13 2. On February 20, 2018, the Court set a March 12, 2018, hearing on the Motion
14 Regarding the Protective Order and Depositions. (2/20/18 Minute Order.)

15 3. On February 22, 2018, the Court granted the parties’ stipulation setting a briefing
16 schedule on the Motion Regarding the Protective Order and Depositions and resetting the hearing
17 date for 9:30 a.m. on Monday, April 2, 2018. (ECF No. 131.)

18 4. The Motion Regarding the Protective Order and Depositions is fully briefed and
19 pending before this Court.

21 5. Plaintiffs filed their Motion to Substitute on February 23, 2018.

22 6. The Motion to Substitute is fully briefed and pending before the Court.

23 7. On March 21, 2018, the Court scheduled a hearing on Plaintiffs’ Motion to
24 Substitute for 9:30 a.m. on Monday, April 2, 2018. (3/21/18 Minute Order.)

25 8. On March 27, 2018, the parties submitted a stipulation to continue the April 2
26 hearing on the Motions to May 1, 2018 (ECF No. 149), which the Court entered on March 28,
27 2018 (ECF No. 151).

1 9. Plaintiffs' counsel now have a conflict and are unable to attend the May 1, 2018,
2 hearing on the Motions.

3 10. Plaintiffs' counsel have conferred with Defendants' counsel about continuing the
4 hearing.

5 11. After discussion, the parties' counsel agreed upon three dates that could
6 accommodate their respective schedules: June 12, 2018, June 13, 2018, and June 14, 2018.

7 12. Defendants' counsel do not object to continuing the hearing to one of these dates
8 subject to the Court's availability on those dates.

9 13. The parties therefore request that the Court reschedule the hearing on the Motions
10 to June 12, 2018, June 13, 2018, or June 14, 2018, or such other date on which the Court is
11 available.
