Dispositive Motions shall be filed and served no later than thirty (30) days after the close of discovery, or October 20, 2017. 8 6. The Joint Pretrial Order is due thirty (30) days after the dispositive motions deadline, or on 9 November 20, 2017. If dispositive motions are filed, the joint pretrial order is due thirty (30) days from 10 the entry of the court's rulings on the motions or by further order of the court. 12 7. The Interim Status Report is due sixty (60) days prior to discovery cut-off or July 20, 2017. 13 8. EXTENSIONS OF DISCOVERY: Pursuant to LR 26-4, an extension of the discovery deadline will not be allowed without a showing of good cause.
