(ECF No. 70). Bank of America, N.A. has filed a 15 response (ECF No. 71), and SFR has filed a reply (ECF No. 72). 16 SFR requests that the court certify the following question to the Nevada Supreme Court: 17 "Whether NRS § 116.31168(1)'s incorporation of NRS § 107.090 requires homeowners' 18 associations to provide notices of default to banks even when a bank does not request notice?" 19 (ECF No. 70 at 1). 20 The court declines to certify this question as controlling precedent is available for guidance. 21 The Ninth Circuit, in Bourne Valley—which SFR cites to in its motion—expressly answered this 22 exact question in the negative. See Bourne Valley Court Trust v. Wells Fargo Bank, NA, 832 F.3d 23 1154, 1159 (9th Cir. 2016). More specifically, the Ninth Circuit held, in relevant part, as follows: 24 Bourne Valley argues that Nevada Revised Statute section 116.31168(1), which incorporated section 107.090, mandated actual notice to mortgage lenders whose 25 rights are subordinate to a homeowners' association super priority lien. . . . According to Bourne Valley, this incorporation of section 107.090 means that 26 foreclosing homeowners' associations were required to provide notice to mortgage lenders even absent a request. 27 If section 116.31168(1)'s incorporation of section 107.090 were to have required 28 homeowners' associations to provide notice of default to mortgage lenders even

1	absent a request, section 116.31163 and section 116.31165 would have been meaningless. We reject Bourne Valley's argument.
2	Id. Therefore, the court will deny SFR's motion.
3	Accordingly,
4	IT IS HEREBY ORDERED, ADJUDGED, and DECREED that SFR's motion to certify
5	(ECF No. 70) be, and the same hereby is, DENIED.
6	The clerk shall enter judgment accordingly and close the case.
