James C. Mahan U.S. District Judge general that a statute has been questioned" under 28 U.S.C. § 2403. FED. R. CIV. P. 5.1(b). Section 2403 states that the court "shall permit the [s]tate to intervene for presentation of evidence, if evidence is otherwise admissible in the case, and for argument on the question of constitutionality." 28 U.S.C. § 2403(b).

In light of the foregoing rule and statute, the court will deny plaintiff and defendants'
motions without prejudice to allow: (1) Green Tree to file a notice of constitutional question, (2)
the court to comply, and (3) the attorney general to intervene. The parties may renew their motions
after the attorney general has been afforded time to respond.

IT IS FURTHER ORDERED that Green Tree Servicing LLC shall promptly file a notice
of constitutional question, pursuant to Federal Rule of Civil Procedure 5.1(a)(1)(B).

IT IS FURTHER ORDERED that this court certifies to the Nevada attorney general that it may rule on the constitutionality of the state statute at issue in this case, NRS 116.3116. The attorney general shall have thirty (30) days within which to intervene on behalf of the state of Nevada for presentation of argument on the question of the constitutionality of the statute.
