14	I. DISCUSSION		
15	Plaintiff, who is a prisoner in the custody of the Clark County Detention Center, has		
16	submitted a civil rights complaint pursuant to 42 U.S.C. § 1983 and has filed an application to		
17	proceed <i>in forma pauperis</i> . (ECF No. 1, 1-1).		
18	Plaintiff's application to proceed in forma pauperis is incomplete. Pursuant to 28 U.S.C.		
19	§ 1915(a)(2) and Local Rule LSR 1-2, Plaintiff must complete an application to proceed in		
20	forma pauperis and attach both an inmate account statement for the past six months and a		
20	properly executed financial certificate. Plaintiff has not submitted an inmate account		
	statement. (See ECF No. 1). As such, the <i>in forma pauperis</i> application is denied without prejudice. The Court will retain Plaintiff's civil rights complaint (ECF No. 1-1), but will not file

23	it until the matter of the payment of the filing fee is resolved. Plaintiff will be granted an		
24	opportunity to cure the deficiencies of his application to proceed in forma pauperis, or in the		
25	alternative, pay the full filing fee for this action. If Plaintiff chooses to file a new application to		
26	proceed in forma pauperis he must file a ful	ly complete application to proceed in forma	
27	pauperis.

1	II. CONCLUSION	
2	For the foregoing reasons, IT IS ORDERED that Plaintiff's application to proceed in	
3	forma pauperis (ECF No. 1) is DENIED without prejudice to file a new application.	
4	IT IS FURTHER ORDERED that the Clerk of the Court SHALL SEND Plaintiff the	
5	approved form application to proceed in forma pauperis by a prisoner, as well as the document	
6	entitled information and instructions for filing an <i>in forma pauperis</i> application.	
7	IT IS FURTHER ORDERED that within thirty (30) days from the date of this order,	
8	Plaintiff shall either: (1) file a fully complete application to proceed in forma pauperis, on the	
9	correct form with complete financial attachments in compliance with 28 U.S.C. § 1915(a); or	
10	(2) pay the full \$400 fee for filing a civil action (which includes the \$350 filing fee and the \$50	
11	administrative fee).	
12	IT IS FURTHER ORDERED that if Plaintiff does not timely comply with this order,	
13	dismissal of this action may result.	
14	IT IS FURTHER ORDERED that the Clerk of the Court shall retain the complaint (ECF	
15	No. 1-1), but shall not file it at this time.
