23 The parties continue to meet and confer on outstanding discovery. In particular, the

 25 dispute in the related state court case is still pending, as the third-party that complains of
 26 impermissible disclosure has retained counsel to assist in that dispute. Plaintiff and related-
 27 case Defendant Christeyns have agreed to seek the further period of discovery in that case –

1 a stipulation between those parties has now been prepared and circulated. That state-court
2 stipulation will be filed in the next week.

6 The parties will file a Status Report with the Court by January 18, 2018.

7 This stipulation is made in good faith and is not for the purposes of delay.
