18 settlement conference on January 28, 2020. [ECF #100].
- 19 5. Plaintiff's counsel has been required to devote time and attention to numerous
20 other pending legal matters since the filing of the subject Motions which has
21 detracted from the time available prepare a response. Plaintiff's counsel has
22 further been ill for the better part of the last week.
- 23 6. In addition, the parties desire to explore settlement in advance of the settlement
24 conference that is scheduled to take place on January 28, 2020, before expending
25 additional resources.
- 26 7. Based upon the foregoing, the parties hereto stipulate and agree that Plaintiff shall
27 have an additional period of time until November 18, 2019, in which to respond to
28 the Defendants' pending Motions for Summary Judgment [ECF #86, 87], and to


