1 1. Effective May 18, 2011, Beazer Mortgage Corporation, through Mortgage Electronic
2 Registration Systems, Inc., assigned its right, title and interest in the deed of trust at issue in the
3 instant case to U.S. Bank, National Association as Trustee for Harborview Mortgage Loan Trust
4 2005-8, Mortgage Loan Pass-Through Certificates, Series 2005-8 pursuant to an Assignment of
5 Deed of Trust (**Assignment**) recorded in the Office of the Clark County Recorder as Instrument
6 201105180000640. A copy of the Assignment is attached as **Exhibit A**.

7 2. Based on the foregoing, U.S. Bank, National Association as Trustee for Harborview
8 Mortgage Loan Trust 2005-8, Mortgage Loan Pass-Through Certificates, Series 2005-8 is now the
9 owner and holder of the deed of trust at issue in the instant action and is therefore the real party in
10 interest. As a result, U.S. Bank, National Association as Trustee for Harborview Mortgage Loan
11 Trust 2005-8, Mortgage Loan Pass-Through Certificates, Series 2005-8 should be substituted for
12 "U.S. Bank, N.A., form and type of entity known" as party-defendant and counterclaimant.

13 3. As a result of the substitution of party-defendant and counterclaimant, the case
14 caption should be amended to read: Goldsmith Enterprises, LLC, a Nevada limited liability
15 company, Plaintiff/Counter-defendant, and U.S. Bank, National Association as Trustee for
16 Harborview Mortgage Loan Trust 2005-8, Mortgage Loan Pass-Through Certificates, Series 2005-8
17 Defendant/Counterclaimant.

18 4. No prejudice will result from the granting of this joint motion.


