1 **MEMORANDUM OF POINTS AND AUTHORITIES**

2
3 **I.**

4 **FACTS**

5 As the Court is aware, this case is one of thirty-three related lawsuits (“Related Cases”) sitting before this Court. Recognizing the complexity of litigating these lawsuits simultaneously, 6 the parties agreed to divide the cases into five groups and stagger deadlines in order to streamline 7 the litigation process and avoid overlapping dispositive motion deadlines. (See ECF No. 61, 2:4- 8 1).

9
10 On March 23, 2017, Defendant filed their Motion for Summary Judgment. (ECF No. 68).
11 Defendant also filed three other Motions for Summary Judgment in the related cases.¹

12 In *Bouch v. Eldorado Resorts Corporation, et al.*, the motion consisted of thirty-one
13 pages and thirty-nine exhibits (ECF No. 68), a Notice of Filing (ECF No. 70) and Index of
14 Exhibits (ECF No. 69), totaling approximately 402 (four-hundred and two) pages. In *Olshansky*
15 *v. Eldorado Resorts Corporation, et al.*, the motion consisted of eighteen pages and twenty
16 exhibits (ECF No. 62), a Notice of Filing (ECF No. 64) and Index of Exhibits (ECF No. 63),
17 totaling approximately 271 (two-hundred and seventy-one) pages. In *Parr v. Eldorado Resorts*
18 *Corporation, et al.*, the motion consisted of thirty-one pages and twenty-three exhibits (ECF No.
19 53), a Notice of Filing (ECF No. 55) and Index of Exhibits (ECF No. 54), totaling approximately
20 261 (two-hundred and sixty one) pages. In *Sekkatv. Eldorado Resorts Corporation, et al.*, the
21 motion consisted of twenty-five and twelve exhibits (ECF No. 64), a Notice of Filing (ECF No.
22 66) and Index of Exhibits (ECF No. 65), totaling approximately 261 (two-hundred and sixty one)
23 pages.

1 Since March 23, 2017, there's been almost daily depositions or cancelled depositions that
2 took place. Furthermore, Plaintiffs' law firm, Watkins & Letofsky, brought back an associate
3 from Medical Leave to help with the instant case and Related Cases. Defense Counsel felt there
4 might be a conflict of interest with the specific associate and she was taken off the case as a
5 courtesy to Defendants. However, a new associate has not yet been hired to replace her tasks on
6 the Related Cases.

7 The current deadline for Plaintiff to respond to Defendants' dispositive motions is April
8 24, 2017. Plaintiff files this current motion seeking an extension until May 15, 2017 to provide a
9 meaningful response to Defendants' Motions for Summary Judgment.

10 II.

11 ARGUMENT

12 A. LEGAL STANDARD FOR EXTENSION OF TIME

13 Federal Rule of Civil Procedure, Rule 6 (b) EXTENDING TIME.

14 (1) *In General.* When an act may or must be done within a specified time,
the court may, for good cause, extend the time:

15 (A) with or without motion or notice if the court acts, or if a request
16 is made, before the original time or its extension expires; or

17 (B) on motion made after the time has expired if the party failed to
18 act because of excusable neglect.

19 Federal Rule of Civil Procedure 6(b)(1)(A) permits a party to extend a deadline prior to
20 its expiration upon a showing of "good cause." The standard to be applied by a court under
21 FRCP 6(b)(1) is a liberal one in order to "effectuate the general purpose of seeing that cases are
22 tried on the merits." *Ahanchian v. Xenon Pictures, Inc.*, 624 F.3d 1253, 1258-59 (9 Cir. 2010).
23 "Good cause is a non-rigorous standard that has been construed broadly across procedural and
24 statutory contexts." *Id* at 1259.

25 "Consequently, requests for extensions of time made before the applicable deadline has
26 passed should 'normally ... be granted in the absence of bad faith on the part of the party seeking
27 relief or prejudice to the adverse party.'" *Id.* (Internal citation omitted).

1 Here, Plaintiff's counsel was served with the instant Motion for Summary Judgment on
2 March 23, 2017. Also on March 23, 2017, Plaintiff's counsel was served with three other
3 motions for summary judgment in the Related Cases.²

4 Plaintiff has good cause to request this timely³ extension of the deadlines to respond to
5 Defendants' four simultaneous filings of their Motions for Summary Judgment because of the
6 sheer volume and size of the motions in addition to the mass amount of evidence⁴ obtained in
7 discovery to refute the motions and the subtleties and nuances between the FMLA and ADA
8 causes of action in these specific cases.

9 For example, in *Bouch v. Eldorado Resorts Corporation, et al.*, the motion consisted of
10 thirty-one pages and thirty-nine exhibits (ECF No. 68), a Notice of Filing (ECF No. 70) and
11 Index of Exhibits (ECF No. 69), totaling approximately 402 (four-hundred and two) pages. In
12 *Olshansky v. Eldorado Resorts Corporation, et al.*, the motion consisted of eighteen pages and
13 twenty exhibits (ECF No. 62), a Notice of Filing (ECF No. 64) and Index of Exhibits (ECF No.
14 63), totaling approximately 271 (two-hundred and seventy-one) pages. In *Parr v. Eldorado*
15 *Resorts Corporation, et al.*, the motion consisted of thirty-one pages and twenty-three exhibits
16 (ECF No. 53), a Notice of Filing (ECF No. 55) and Index of Exhibits (ECF No. 54), totaling
17 approximately 261 (two-hundred and sixty one) pages. In *Sekkatv. Eldorado Resorts*
18 *Corporation, et al.*, the motion consisted of twenty-five and twelve exhibits (ECF No. 64), a
19 Notice of Filing (ECF No. 66) and Index of Exhibits (ECF No. 65), totaling approximately 261
20 (two-hundred and sixty one) pages.

21 It would be challenging to respond to a single Motion for Summary Judgment of this size
22 and magnitude within the time frame required. However, responding to all four is simply
23 impractical. The amount of depositions being conducted and the overlap of motions including

1 the amount of exhibits and evidence in the instant case and Related Cases has put Plaintiff in a
2 position of needing until May 15, 2017, to respond to Defendants' dispositive motions.
