

1 On October 14, 2016, the Court entered a Discovery Plan and Scheduling Order setting  
2 deadlines through dispositive motions (ECF No. 311). On June 1, 2017, the Court heard argument  
3 on Plaintiffs' Request for an Extension of Time concerning those deadlines (ECF No. 414) and  
4 ordered that the fact discovery deadline be extended to July 31, 2017 and the deadline for  
5 Plaintiffs' expert reports be extended to August 31, 2017, with other case deadlines extended  
6 accordingly (*see* ECF No. 422). To provide dates certain for the respective case deadlines, the  
7 parties have met and conferred and stipulated to the following deadlines in accordance with the  
8 Court's Order, adjusted to account for deadlines falling on weekends and deadlines falling on or  
9 around holidays:
