15 On June 4, 2015, the five above-captioned cases were transferred into this District pursuant  
16 to an order transferring them from the Northern District of California. Plaintiffs and Defendant  
17 filed a Notice of Related Cases in all five cases. There are also pending Motions to Consolidate in  
18 case no. 2:15-cv-01045-RFB-PAL (ECF No. 52), case no. 2:15-cv-01055-APG-GWF (ECF No.  
19 29), and case no. 2:15-cv-01056-RFB-GWF (ECF No. 29), as well as a pending Motion to Relate  
20 Case in case no. 2:15-cv-01055-APG-GWF (ECF No. 26).

21 The presiding District Judges in these actions have determined that these actions are related  
22 and that there is good cause to consolidate them under the same District Judge and Magistrate  
23 Judge. Neither party opposes consolidation. Further, consolidation will promote judicial  
24 efficiency, avoid duplicative filings by the parties, and will not result in prejudice to the parties.

25 **ORDER**

26 Therefore,

27 **IT IS HEREBY ORDERED** that case no. 2:15-cv-01045-RFB-PAL, no. 2:15-cv-01046-  
28 RCJ-NJK, no. 2:15-cv-01055-APG-GWF, no. 2:15-cv-01056-RFB-GWF, and no. 2:15-cv-01057-  
JCM-CWH are CONSOLIDATED, with case no. 2:15-cv-01045-RFB-PAL to serve as the lead

1 case and the other cases serving as member cases. All further documents shall be filed in the lead  
2 case 2:15-cv-01045-RFB-PAL and shall bear that case number.

3 **IT IS FURTHER ORDERED** that case no. 2:15-cv-01046-RCJ-NJK, no. 2:15-cv-01055-  
4 APG-GWF, no. 2:15-cv-01056-RFB-GWF, and no. 2:15-cv-01057-JCM-CWH are  
5 REASSIGNED to District Judge Richard F. Boulware, II, and Magistrate Judge Peggy A. Leen  
6 for all further proceedings.

7 **IT IS FURTHER ORDERED** that the Motions to Consolidate in case no. 2:15-cv-01045-  
8 RFB-PAL (ECF No. 52), case no. 2:15-cv-01055-APG-GWF (ECF No. 29), and case no. 2:15-cv-  
9 01056-RFB-GWF (ECF No. 29) are GRANTED.

10 **IT IS FURTHER ORDERED** that the Motion to Relate Case in case no. 2:15-cv-01055-  
11 APG-GWF (ECF No. 26) is GRANTED.
