| 15 | COME NOW, the parties, by and through their attorneys of |
| 16 | record, and hereby stipulate and agree to extend the time for the |
| 17 | remaining briefing with respect to the motions for summary judgment. |
| 18 | Plaintiffs' summary judgment motion (Docket No. 34) was filed May |
| 19 | 25, 2017. Both Plaintiffs and Defendant filed motions for summary |
| 20 | judgment on May 25 th and their respective responses are due June |
| 21 | 15 th . The parties request fourteen (14) day extensions for filing |
| 22 | responses and reply briefs. Responses would be due June 29, 2017, |
| 23 | and the reply briefs (normally due fourteen (140 days later) would |
| 24 | be due July 27, 2017. This is the first request to extend the time |
| 25 | for filing the remaining summary judgment briefs and is not made for |
| 26 | any reason of delay but because of counsels' recent work commitments |
| 27 | and July schedules. |
| 28 | Since the filing of the motions for summary judgment, defense |

counsel has motions for summary judgment due in two other federal

1 cases (plus responses due in one of those matters to the plaintiff's 2 recent requests to reopen discovery and amend complaint) prior to June 15th, a response due to an OSHA employee retaliation complaint, 3 an employee dismissal arbitration on June 6th, and will be in 4 5 depositions for several days in another federal case to conclude depositions by the June 15th discovery deadline in that matter. 6 Additionally defense counsel's office is moving June 9th so his 7 office must be packed by the end of June 8th and the move, including 8 computers, is to take place on June 9th and through the weekend, 9 10 therefore it is expected this will take up defense counsel's time immediately before June 8th and into the next week. Plaintiffs' 11 12 counsel has been involved in two (2) arbitrations since the filing 13 of the motions for summary judgment and recently had the briefing schedule restarted without prior notice in a complex appellate 14 15 matter that had been stayed which is expected to take significant 16 time.
