- 1. Plaintiff, T-Rex Property AB, and Defendant, Las Vegas Billboards, LLC, (collectively, "the Parties") file this Stipulation to Extend Defendant Las Vegas Billboards, LLC's Deadline to Answer or Otherwise Respond to Plaintiff's Complaint and in support thereof would respectfully show the Court as follows:
- 2. Plaintiff commenced this action by filing its Complaint on July 8, 2015, in the United States District Court for the District of Nevada. Defendant's original deadline to answer Plaintiff's Complaint was August 4, 2015, based on service on July 14, 2015 of Plaintiff's Complaint (DKT. 14).
- 3. Based on the agreement and stipulation of the Parties, Defendant Las Vegas Billboards, LLC's deadline to answer or otherwise respond to Plaintiff's Complaint was extended by thirty (30) days to September 3, 2015.
- 4. The Parties make a second request for extension and stipulation, based upon ongoing settlement discussions. By agreement of the Parties, the Parties respectfully request that the Court enter an Order extending Defendant's deadline to answer or otherwise respond by thirty (30) days from September 3, 2015 to (and
