1           1.           Plaintiff, T-Rex Property AB, and Defendant, Las Vegas Billboards,  
2 LLC, (collectively, “the Parties”) file this Stipulation to Extend Defendant Las Vegas  
3 Billboards, LLC’s Deadline to Answer or Otherwise Respond to Plaintiff’s Complaint  
4 and in support thereof would respectfully show the Court as follows:

5           2.           Plaintiff commenced this action by filing its Complaint on July 8, 2015,  
6 in the United States District Court for the District of Nevada. Defendant’s original  
7 deadline to answer Plaintiff’s Complaint was August 4, 2015, based on service on July  
8 14, 2015 of Plaintiff’s Complaint (DKT. 14).

9           3.           Based on the agreement and stipulation of the Parties, Defendant Las
