**STIPULATION AND ORDER
 CONTINUING HEARING ON

1 Plaintiffs Aerodynamics Incorporated and ADI Holdings Company, Inc. (collectively
2 “Plaintiffs”), by and through their undersigned counsel, and Defendants Caesars Entertainment
3 Operating Company, Inc., Steven Markhoff, International Management Solutions, LLC, Via
4 Airlines, Inc., Via Air, LLC, and Amos Vizer (collectively “Defendants”), by and through their
5 undersigned counsel, hereby state as follows:

6 WHEREAS, on August 17, 2015, Plaintiffs filed their Motion for Temporary Restraining
7 Order and for a Preliminary Injunction;

8 WHEREAS, on September 24, 2015, the Court granted a limited Temporary Restraining
9 Order and set Plaintiffs’ Motion for Preliminary Injunction (the “Motion”) for hearing on October
10 23, 2015, at 1:30 p.m.;

11 WHEREAS, the parties have fully briefed the Motion;

12 WHEREAS, the parties have agreed to work in good faith to attempt to resolve the Motion
13 which could render further proceedings on Plaintiffs’ Motion unnecessary;

14 WHEREAS, Plaintiffs and Defendants are currently in the process of negotiating the
15 potential resolution but, due to the shortness of time before the presently scheduled hearing,
16 anticipate that an agreement may not be reached by October 23, 2015 (the date presently set for the
17 hearing); and

18 WHEREAS, in the interests of judicial efficiency and economy, and to avoid potentially
19 unnecessary proceedings, Plaintiffs and Defendants agree that it would be appropriate to continue
20 the hearing on Plaintiffs’ Motion to give the parties time to negotiate and finalize an agreement.

21 IT IS ACCORDINGLY STIPULATED, by and between the undersigned counsel for the
22 parties, that:

- 23 1. The hearing on Plaintiffs’ Motion for Preliminary Injunction presently scheduled for
24 October 23, 2015, shall, subject to the approval of the Court, be rescheduled for
25 November 9, 2015 at 11:00 a.m., or as soon thereafter as the Court's schedule permits;
26 and

1 2. The parties will continue to negotiate an agreement and will notify the Court whether
2 such an agreement has been reached on or before 4:00 p.m. on November 6, 2015.
