25 participated in a mandatory settlement conference on September 8, 2016, which resulted in the
26 parties reaching a tentative settlement of all remaining claims that was subsequently finalized and
27 confirmed as a full and final settlement of this case one week after the settlement conference;

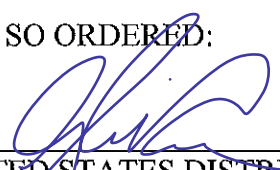
