15 including but not limited to location, value, mortgage, mortgage payments, liens, or the like
16 regarding such real property;

17 A complete current inventory list of assets owned by Service Plumbing, including but not
18 limited to, office equipment, vehicles, and accounts receivable;

19 The last twelve (12) statements for each and every one of Service Plumbing’s bank
20 accounts in existence during such twelve (12) months, without regard to whether such account
21 remains open;

23 Any and all documents regarding real property disposed of by Service Plumbing in the last
24 five (5) years;


