10-112-061 ("Property") is superior to the interest of defendant Foreclosure Sales Services, LLC.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that all transfers of title to the Property are and were subject to Plaintiff's first Deed of Trust, and that the first Deed of Trust continues to encumber title in senior position in the chain of title. IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the HOA Sale was invalid and conveyed no right, title, or interest in the Property to NV Foreclosure Services, LLC or Foreclosure Sales Services, LLC. IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that upon the entry of this Judgment, all the rights and liabilities of all the parties to this action have been adjudicated.
