20 **ORDER GRANTING STIPULATION TO EXTEND DEADLINE TO FILE**
 21 **REPLY IN SUPPORT OF MOTIONS FOR SUMMARY JUDGMENT**
 (First Request)

22 The Bank of New York Mellon fka The Bank of New York, as Trustee for the Benefit of the
 23 Certificate Holders of the CWALT, Inc., Alternative Loan Trust 2005-63, Mortgage Pass Through
 24 Certificates, Series 2005-63 (“BoNYM”) and Copperhead Trails Street and Landscape Maintenance
 25 Corporation (“Copperhead”) hereby stipulate as follows:

26 1. Copperhead had filed a motion for summary judgment on September 17, 2019. (ECF
 27 No. 66.) BoNYM had filed an opposition to the motion on October 21, 2019. (ECF No. 70.) The
 28 reply to the opposition is currently due on November 4, 2019.

1 2. The parties agree that Copperhead will have until **November 18, 2019** to file its reply
2 to BONYM's opposition to the motion for summary judgment.

3 3. This is the first request for an extension of this deadline and is not made for purposes
4 of undue delay, but to allow Copperhead sufficient time to address arguments raised in BoNYM's
5 opposition to the motion for summary judgment.


