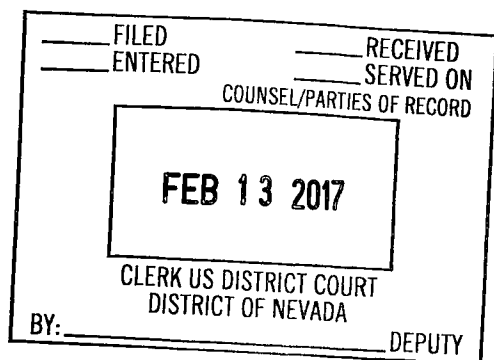

NOTICE OF MOTION FOR EXTENSION OF TIME TO RESPOND TO PLAINTIFF'S MOTION FOR SANCTIONS, PURSUANT TO LR 1A 6-1 (b), FIRST REQUEST

Defendant Clarence Moses Willis hereby respectfully moves this Court for an extension of time of ten (10) days to respond to Plaintiffs' Motion for Sanctions filed on January 26, 2017 (ECF.160). 3 would be due February 12, 2017 (a Sunday).


4 3. Counsel for Plaintiffs has not agreed to Defendants' request to enlarge the time
5 for filing the response by ten (10) days, which would make the new deadline
6 February 22, 2017.

7 4. The extension requested herein is for good cause and will not result in undue
8 delay in the administration of this case. An enlargement of time for filing Defendants'
9 response is necessary due to Defendants' medical treatment schedule.

10 5. Two other enlargement of time to file an Answer has been previously requested in
11 this case (DKT. #'s 33 & 35). No dates have been set for a pre-trial conference or
12 trial.

13 THEREFORE, Defendant Willis respectfully requests that the Court extend the time
14 for responding to Plaintiffs' Motion for Sanctions to February 22, 2017.


