**STIPULATION AND ORDER TO DISMISS
 ACTION WITH PREJUDICE**

1 WHEREAS, Plaintiff SOCIAL BUTTERFLY WORLD, LLC (“SBW”) filed its Complaint
2 on January 22, 2016, and Defendant MENDEZ MEDIA MARKETING, INC. (“MMMI”) filed its
3 answer herein on February 22, 2016;

4 WHEREAS, SBW and MMMI engaged in settlement discussions over the proceeding
5 months, and agreed to a settlement of the above-captioned action;

6 WHEREAS, all parties have executed their respective portions of the settlement agreement,
7 which includes a dismissal with prejudice of the above-captioned suit conditioned on certain terms
8 being performed, which have since occurred.

9 NOW THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and between SBW
10 and MMMI (collectively the “Parties”), through their undersigned counsel, as follows:

11 1. The action in its entirety and Defendant MMMI shall be and hereby are dismissed
12 with prejudice.

13 2. Each party shall bear its own attorneys’ fees and costs.

14 3. The other terms of the settlement shall remain confidential, except as otherwise stated
15 in the settlement agreement.

16 4. The Parties are currently scheduled to appear at a settlement conference before Hon.
17 Nancy Koppe on January 11, 2017, with confidential briefs due by January 4, 2017. The Parties
18 respectfully submit that these matters should be vacated and removed from the Court’s calendar.
19 There are currently no other pending hearings or matters before this Court.
