19 MEMORANDUM OF POINTS AND AUTHORITIES

20 On September 01, 2016, the Probate Court of the Eighth Judicial District Court, Clark  
21 County, Nevada ("Probate Court"), entered an Order, appointing George C. Swarts, CPA, the  
22 Special Administrator for Plaintiff. A copy of the September 01, 2016 Order of the Probate  
23 Court is attached hereto and incorporated herein as Exhibit "1".

24 Fed. R. Civ. Proc., Rule 25 (a) provides:

25 (a) Death.

26 (1) Substitution if the Claim is Not Extinguished. If a party dies  
27 and the claim is not extinguished, the court may order

1 substitution of the proper party. A motion for substitution may be  
2 made by any party or by the decedent's successor or  
3 representative. If the motion is not made within 90 days after  
4 service of a statement noting the death, the action by or against  
5 the decedent must be dismissed.

6 As Special Administrator, George C. Swarts, CPA, steps into the same position as  
7 Plaintiff.

8 Wherefore, Plaintiff hereby moves this Court for an Order to allow the substitution of  
9 these parties, namely, George C. Swarts, CPA, as Special Administrator for Plaintiff, and  
10 therefore a Plaintiff, herein, instead of Plaintiff, Paul Lopez.

11 Further, Plaintiff seeks the Court's Order directed to the Clerk of the Court, that the  
12 caption and all of the records of this case be changed to show that George C. Swarts, CPA,  
13 is now substituted for Paul Lopez, and as a Plaintiff, herein. A proposed caption is submitted  
14 as Exhibit "2" to this Motion.
