9	On September 28, 2016, Magistrate Judge George Foley, Jr., screened plaintiff Christopher	
10	Amir Weaver's complaint and amended complaint, granted his application for pauper status, and	
11	recommended that I dismiss his claims with limited leave to file a second-amended complaint if he	
12	can cure the deficiencies identified in the Order and Report and Recommendation. ¹ Objections to	
13	that report and recommendation were due by October 15, 2016. Weaver filed no objections and did	
14	not seek an extension of time to do so. ² "[N]o review is required of a magistrate judge's report and	
15	recommendation unless objections are filed." Schmidt v. Johnstone, 263 F. Supp. 2d 1219, 1226 (D.	
16	Ariz. 2003); see also Thomas v. Arn, 474 U.S. 140, 150 (1985); United States v. Reyna-Tapia, 328	
17	F.3d 1114, 1121 (9th Cir. 2003). Accordingly, and with good cause appearing,	
18	IT IS HEREBY ORDERED that Magistrate Judge Foley's Report and Recommendation	
19	[ECF No. 4] is ACCEPTED and his findings and conclusions are adopted;	
20	IT IS FURTHER ORDERED that Weaver's amended complaint is DISMISSED with	
21	prejudice against the State of Nevada, and without prejudice and with leave to file a second-	
22	amended complaint by November 14, 2016, against the other defendants if Weaver can cure the	
23	defects identified in the Order and Report and Recomme	endation [ECF No. 4]. Weaver is advised

5	If Weaver does not file a proper second-amended complaint by November 14, 2016, this	
6	case will be dismissed in its entirety and closed without further prior notice.
