APPURTENANT TO PARCEL ONE (1) TWO (2) AND THREE (3) ABOVE DESCRIBED.

1 3. On September 10, 2012, Park Avenue recorded a Foreclosure Deed as Document Number
2 20120910-0000474 of the Official Records of Clark County, Nevada (the **HOA Foreclosure Deed**),
3 reflecting that Park Avenue purchased the Property at a foreclosure sale of the Property held
4 September 5, 2012 (the **HOA Sale**).

5 4. On February 18, 2016, BANA initiated a quiet title action against Park Avenue and Red
6 Rock in the United States District Court, District of Nevada, Case No. 2:16-cv-00338-JCM-VCF (the
7 **Quiet Title Action**).

8 5. BANA and Park Avenue have entered a confidential settlement agreement in which they
9 have settled all claims between them in this case.

10 6. Among other things, Park Avenue has transferred any and all interest it acquired as a
11 result of the HOA Sale and HOA Foreclosure Deed to BANA, as reflected by the quit-claim deed
12 attached hereto as Exhibit A.
