**STIPULATION AND [PROPOSED ORDER] TO AMEND BRIEFING SCHEDULE ON DEFENDANT NATIONSTAR MORTGAGE, LLC’S MOTION FOR SUMMARY JUDGMENT [ECF No. 50]**

14 currently scheduled for March 22, 2017 in Dallas, Texas. The parties believe these depositions  
15 will produce information relevant to the outstanding Motion for Summary Judgment. As such,
