
1 Defendant David A. Yeakel (“Yeakel”) has been issued [ECF No. 24]; that Cross-Defendant
2 Yeakel is a necessary party; and that Cross-Defendant Yeakel cannot be found to be personally
3 served in the State of Nevada, and good cause appearing therefore,

4 **IT IS HEREBY ORDERED** that since the Cross-Defendant Yeakel, cannot now be found
5 so as to be personally served, he may be served by publication of the Summons at least once a
6 week for four (4) weeks in the Nevada Legal News, a newspaper of general circulation, pursuant
7 to FRCP 4(e)(1) and NRCP 4(e)(1) and in a newspaper of general circulation in Irving, Texas,
8 pursuant to FRCP 4(e)(1) and NRCP 4(e)(1).

9 **IT IS FURTHER ORDERED** that a copy of the Summons and Answer, Counterclaim,
10 and Cross-Claim shall be mailed forthwith to Cross-Defendant David A. Yeakel, first class mail,
11 postage prepaid, addressed to the Cross-Defendant's last known address.

12 **IT IS FURTHER ORDERED** that SFR’s Motion to Enlarge Time to Serve is GRANTED
13 and the time for service is extended by an additional 60 days from the date of this order is entered
14 to allow SFR Investments Pool 1, LLC (“SFR”) to effectuate service by publication.
