

1 Under the current Discovery Plan and Scheduling Order entered on June 28, 2016 (Doc.
2 #22), the deadline for filing the response to initial non- infringement, invalidity, and
3 unenforceability contentions (LPR 1-10) is September 26, 2016. The parties are currently
4 engaged in settlement discussions which may resolve the claims of this litigation. In order to
5 allow the parties additional time to continue ongoing settlement discussions before a response is
6 due, the parties request that the current deadline be extended nine (9) days until Wednesday,
7 October 5, 2016. The litigation of this matter will be best served by the proposed extension.

8 Accordingly, Plaintiff and Defendant respectfully request that the Court grant this
9 request to continue the deadline for Filing Response to Initial Non- Infringement, Invalidity, and
10 Unenforceability Contentions (LPR 1-10) until October 5, 2016.
