23 Plaintiff John Lige, by and through his attorney of record, Dan M. Winder, Esq. of the
 24 Law Office of Dan M. Winder, P.C., and Defendant Clark County, by and through its attorney of
 25 record, Danielle C. Miller, Esq. of Lewis Brisbois Biggaard & Smith, hereby stipulate and agree:

- 26 1. The Joint-Pretrial Order in this matter is to be filed by up to and including Monday,
 27 Monday, May 7, 2018.

1 The reasons for this request are the following:

2 1. In the last week or so and in the next two weeks, Plaintiff's counsel has been and will
3 be working to meet the at least following inordinate amount of deadlines:


