**STIPULATION AND ORDER FOR
 DISMISSAL WITH PREJUDICE AS TO
 DEFENDANT SERVICE EMPLOYEES
 INTERNATIONAL UNION, LOCAL 1107**

17 Plaintiff, John Lige, by and through his counsel of record, Law Office of Dan Winder,
 18 P.C.; Defendant, Service Employees International Union, Local 1107 (“Local 1107”), by and
 19 through its counsel of record, The Urban Law Firm; and Defendant, Clark County, by and
 20 through its counsel of record, Lewis Brisbois Bisgaard & Smith, LLP, hereby stipulate and agree
 21 as follows, subject to the approval and Order of the Court:

- 22 1. A full and final settlement of the above-entitled action has been entered into and
 23 agreed to by Plaintiff and Local 1107.
- 24 2. Plaintiff and Local 1107 have executed a Settlement Agreement setting forth the
 25 terms of their settlement.
- 26 3. The Court approved the settlement as a good faith settlement on October 25, 2016
 27 (ECF No. 60).

1 4. Therefore, the parties do hereby request that this action be dismissed with
2 prejudice as to Local 1107 only, with each side (Plaintiff and Local 1107) to bear its own
3 attorney's fees and costs.

4 5. In light of the approval of the settlement as a good faith settlement, Defendant
5 Clark County consents to the dismissal with prejudice of Local 1107 from this action.


