**JOINT STIPULATION AND

 25 Plaintiff Lee C. Kamimura (“Plaintiff”) and Defendant Ditech Financial LLC,  
 26 fka Green Tree Services LLC (“Defendant” and together with Plaintiff, the  
 27

1 “Parties”) by and through their counsel of record hereby stipulate to extend the  
2 motions deadline in this case as follows:

3 (1) The deadline for Defendant to file its opposition to Plaintiff’s motion for  
4 class certification will be March 28, 2018.

5 (2) The deadline for Plaintiff to file his reply will be April 11, 2018.

6 The current deadline to file dispositive motions is March 21, 2018. ECF No.  
7 59.

8 Good cause exists to amend the deadline by which Defendant must file its  
9 opposition to Plaintiff’s Motion for Class Certification. The parties originally  
10 agreed that Defendant would have three weeks to respond to the Motion. ECF No.  
11 26, p. 3:14-16; ECF No. 40, p. 2:18-20; ECF No. 42, p. 2:15-18; and ECF No. 42, p.  
12 2:12-15. When the parties stipulated that Plaintiffs could have an extension to file  
13 the Motion for Class Certification, they inadvertently failed to include Defendant’s  
14 response date in that stipulation. ECF No. 52. Therefore, this stipulation is  
15 necessary to effectuate the parties’ agreement that Defendant will have 21 days to  
16 respond to Plaintiff’s Motion for Class Certification.

17 The Parties are also continuing to actively discuss an informal resolution to  
18 this matter.

19 The Parties respectfully propose the following briefing schedule:

20 (1) The deadline for Defendant to file its opposition to Plaintiff’s motion for  
21 class certification will be March 28, 2018.

22 (2) The deadline for Plaintiff to file his reply will be April 11, 2018.

23 The Court has not yet set a hearing for the Motion for Class Certification.  
24 Therefore, these seven-day extensions will not affect any previous hearing dates set  
25 by the Court.


