21	complaint (ECF No. 104) and to refile for failure to comply with Local Rule IC 2-2(b). (ECF No.	
22	106).	
23	On October 12, 2017, the parties filed: (1) a second stipulation and order to lift stay (ECF	
24	No. 107); (2) a second stipulation and order for amended joint discovery plan (ECF No. 108); and	
25	(3) refiled a stipulation and order to amend complaint to reassert a breach of NRS 116.3116 and	
26	wrongful foreclosure claims (ECF No. 109).	
27	On October 13, 2017, Magistrate Judge Foley granted the parties' stipulation and order to	
28	lift stay (ECF No. 103). (ECF No. 110). Also on October 13, 2017, Magistrate Judge Foley
