FHFA filed its Motion for Leave to File Amicus Curiae Brief (the 'Motion") on November
 22, 2017 (ECF No. 91). SFR filed its Motion to Strike the Motion (ECF No. 92) and Response to
 the Motion (ECF No. 93) on November 24, 2017.

The parties stipulated that, rather than have two due dates for FHFA's reply and response, FHFA would have until the later date of December 8, 2017 to file a combined reply/response (ECF No. 96).

FHFA did not file its reply and response until December 11, 2017 (ECF No. 98). In its
reply, FHFA stated its position that it believed SFR's motion to strike/response to the Motion was
simply a response to the Motion and leave should not be given for SFR to file a reply to the motion
to strike. SFR disagrees.

SFR counsel with primary responsibility for this issue has had both car and family health issues that prevented her from completing SFR's reply in support of its motion to strike.

While the parties disagree as to the propriety of the reply (see ECF No. 98), the parties agree that additional time for SFR to reply or take further action is appropriate under the circumstances, with FHFA reserving its rights to object to the filing based on its position, if necessary.

IT IS HEREBY AGREED AND STIPULATED to extend the deadline for SFR to file its
reply in support of its motion to strike, or take such further action as is deemed necessary, from
December 18, 2017 to December 22, 2017.
