1 A settlement conference was held in the above referenced matter on October 30, 2018. The  
2 parties were unsuccessful in reaching a settlement agreement. Prior to the settlement conference, a  
3 Stipulation and Order was entered extending the time for filing the Joint Pretrial Order to 30 days after  
4 the settlement conference, if a settlement was not reached. Accordingly, the Joint Pretrial Order is  
5 currently due on or before November 29, 2018.

6 On November 6, 2018, Defendants Hi-Tech Security, Inc. and William Roseberry filed their  
7 Association of Counsel. With new counsel recently having been brought in for said Defendants and  
8 in light of multiple personal and professional duties which have interfered with and consumed time  
9 set aside by all counsel to prepare the aforementioned Joint Pretrial Order, all parties have agreed to  
10 extend the time for filing the Joint Pretrial Order by 30 days, subject to this Court's approval. As the  
11 30<sup>th</sup> day from the current deadline falls on a Saturday and the following Monday is New Year's Eve,  
12 the parties hereby request that the deadline to file the Joint Pretrial Order to be extended to January 2,  
13 2019.

14 This Stipulation is submitted in good faith and is not interposed for purposes of delay. **This is**  
15 **the second request to extend the deadline for filing the Joint Pretrial Order.**


