**EXTEND DEADLINES REGARDING**  
**MOTION TO DISMISS**

**(First Request)**

21 Plaintiffs, Chad Kreiser and Christina Kreiser, by and through their counsel of record,  
22 Peter S. Christiansen, Esq., R. Todd Terry, Esq., and Keely A. Perdue, Esq. of Christiansen Law  
23 Offices, and Defendant Kiewitt Infrastructure West Co., by and through its counsel of record, J.  
24 Bruce Alverson, Esq. and Karie N. Wilson, Esq. of Alverson Taylor Mortensen & Sanders,  
25 pursuant to LR IA 6-1(b) hereby stipulate and agree to extend the deadlines associated with  
26 Defendant Kiewit Western Co. d/b/a Lake Mead Constructor’s Motion to Dismiss or  
27 alternatively, Motion for Summary Judgment (“Motion”) filed on May 11, 2018 (Dkt. No. 46),  
28 as follows:

1 WHEREAS, Defendant filed its Motion on May 11, 2018;  
2 WHEREAS, Plaintiffs' opposition is due on or before May 25, 2018; however,  
3 Plaintiff's counsel will be out of the jurisdiction the week the opposition is due;

4 WHEREAS, Defendant's reply brief would have been due 7 days immediately  
5 following the filing of Plaintiffs' opposition.

6 IT IS STIPULATED AND AGREED that Plaintiffs' opposition shall be due on or  
7 before June 8, 2018 to allow Plaintiff's counsel sufficient time to oppose Defendant's Motion  
8 on its merits.

9 IT IS FURTHER STIPULATED AND AGREED that Defendant's reply shall be due on  
10 or before June 15, 2018 or 7 days immediately following the filing of Plaintiffs' Opposition,  
11 whichever comes first.

12 This is the first stipulation for extension of time to extend deadlines regarding  
13 Defendant's Motion to Dismiss.
