This is the parties' 24 first request for an extension of time. 25 26

Defendant Kiewit's Motion for Summary Judgment was filed on September 17, 2019, with the deadline for the parties' Opposition being October 8, 2019. Good cause exists for the requested extension because discovery is still ongoing. On October 3, 2019, the parties submitted a Stipulation and Order to Extend Discovery for 60 days, which was granted. The deposition of Defendant Kiewit Western Co.'s FRCP 30(b)(6) designee is currently scheduled to take place on November 4, 2019. This testimony is necessary for the parties to adequately respond to Defendant Kiewit's Motion for Summary Judgment. As discovery is still ongoing, Plaintiffs have requested additional time to respond to Defendant's Motion for Summary Judgment. Defendant will in turn require additional time to prepare a reply in support of Defendant's Motion.
