 17 **I. INTRODUCTION**

18 Defendant Nancy A. Berryhill, Acting Commissioner of Social Security (“Defendant”)   
 19 respectfully requests that the Court extend the time for Defendant to file her Answer to the   
 20 Complaint, due on July 18, 2017 by 30 days, through and including August 17, 2017.
