9 Wells Fargo Bank, N.A. (“Wells Fargo”), Federal Home Loan Mortgage Corporation
10 (“Freddie Mac”), Collegium Fund Series 32 (“Collegium Fund”), Absolute Collection Services, LLC
11 (“ACS”), and Nuevo Vista Homeowners Association, Inc. (the “HOA”), by and through their
12 respective counsel, hereby respectfully request that the Court enter an order, pursuant to Local Rules
13 6-1 and 7-1, extending the time for Collegium Fund, ACS, and the HOA to respond to the Motion
14 for Summary Judgment (the “MSJ”) filed by Freddie Mac on January 17, 2017 [ECF No. 26] and
15 joined by Wells Fargo on January 20, 2017 [ECF No. 29]. The response to the MSJ is currently due
16 on March 7, 2017. The Parties have agreed to extend this response date to March 28, 2017.

17 The extension is being sought in good faith and will not unduly delay this litigation. Freddie
18 Mac has recently discovered additional documents that may be responsive to Collegium Fund’s
19 discovery requests. Freddie Mac is in the process of reviewing the documents for production.
20 Collegium Fund, the HOA, and ACS would like some time to review these additional documents
21 before responding to the MSJ.

22 Accordingly, the Parties respectfully request that the Court grant this Stipulation and extend
23 the time to respond to the MSJ from March 7, 2017 to March 28, 2017.
