**ORDER GRANTING MOTION TO  
 ENLARGE TIME TO SERVE SUMMONS  
 AND CROSS-CLAIM**

Upon reading the Affidavit of Due Diligence; it appearing that an Answer, Counterclaim, and Cross-Claim has been filed; that a Summons directed to Cross-Defendant, ANDREW E. CATO ("Cato") has been issued [ECF No. 21]; that Cross-Defendant, Cato is a necessary party;

1 and that Cross-Defendant Cato cannot be found to be personally served in the State of Nevada,  
2 and good cause appearing therefore,

3 **IT IS HEREBY ORDERED** that since the Cross-Defendant, ANDREW E. CATO, cannot  
4 now be found so as to be personally served, he may be served by publication of the Summons at  
5 least once a week for four (4) weeks in the Nevada Legal News, a newspaper of general circulation,  
6 pursuant to FRCP 4(e)(1) and NRCP 4(e)(1) and least once a week for four (4) weeks in a  
7 newspaper of general circulation in the Seattle, Washington metropolitan area, pursuant to FRCP  
8 4(e)(1) and NRCP 4(e)(1).

9 **IT IS FURTHER ORDERED** that a copy of the Summons and Answer, Counterclaim,  
10 and Cross-Claim shall be mailed forthwith to Cross-Defendant Cato, first class mail, postage  
11 prepaid, addressed to the Cross-Defendant's last known address.

12 **IT IS FURTHER ORDERED** that SFR's Motion to Enlarge Time to Serve is GRANTED  
13 and the time for service is extended by an additional 60 days from the date of this order is entered  
14 to allow SFR Investments Pool 1, LLC ("SFR") to effectuate service by publication.
