Wells Fargo Bank, N.A., 832 F.3d 1154 (9th Cir. 2016) in light of the Nevada Supreme Court's decision in Bank of America, N.A. v. SFR

Investments Pool, LLC, 427 P.3d 113 (Nev. 2018). Because the instant case raises similar issues and
procedural posture, the Ninth Circuit was inclined to vacate the district court's decision and remand
for further consideration. No objections were filed, and the case was remanded on July 18, 2019
[ECF No. 45] for further proceedings.

Based on the remand, the parties stipulate that re-filing summary judgment motions is appropriate and agree summary judgment briefs shall be due **September 16, 2019.**
