**STATUS REPORT ON
NOTICE OF SETTLEMENT**

26 On or about 3/01/2017, LYNN D. TRAVERS (the “Plaintiff”) and WELLS
27 FARGO HOME MORTGAGE (the “Defendant” or “WELLS FARGO”)(hereinafter
28 collectively the “Settling Parties”) settled their respective disputes in this matter.

Pursuant to the Court’s Order entered on March 7, 2017, the Settling Parties were
to file dismissal paperwork by May 2, 2017 or provide a status report outlining what is
impeding settlement and full resolution in this matter. **See Doc. No. 46.**

1 While dismissal paperwork has not yet been filed, the Settling Parties have
2 negotiated the final terms of a proposed settlement agreement and the settlement terms
3 are being executed.

5 The specific delays in filing dismissal paperwork resulted from a natural time
6 delay in finalizing agreeable credit reporting data to be reported on the Plaintiff's credit
7 report. The Settling Parties both had to consult with their clients to finalize the data
8 which was agreeable to be published by the Defendant. Accordingly, additional time
9 was required to finalize settlement and fulfill the Settling Parties' settlement obligations.

11 The Settling Parties expect to have all outstanding settlement issues resolved
12 within thirty (30) days.
