9 counsel Fennemore Craig, P.C., Blumenthal Nordrehaug & Bhowmik and Gerard & Associates,
10 and Appellee Turnberry/MGM Grand Towers, LLC (“Appellee”, and together with the
11 Appellants, the “Parties”), by and through their counsel, the law firm of Garman Turner Gordon
12 LLP, hereby stipulate and agree as follows:

14 WHEREAS, the deadline for Appellants to file their Opening Brief is **September 30,**
15 **2016**, the deadline for Appellee to file an Answering Brief is **October 17, 2016**, and the deadline
16 for Appellants to file a Reply Brief is **November 3, 2016** (the “Briefing Schedule”).

17 WHEREAS, on September 22, 2016, the Appellants, Appellee and other related parties
18 entered into a Mediation Agreement to settle all claims related to this litigation, including the
19 instant Appeal, which Agreement contemplates the execution of a Settlement Agreement and
20 Release by each of the Appellants.

22 WHEREAS, it will take approximately sixty (60) days from the time the Settlement
23 Agreement and Release is prepared to finalize the pending settlement (the “Settlement”).

24 NOW, THEREFORE, the Parties hereby stipulate and agree as follows:

25 1. The current Briefing Schedule shall be vacated to allow the Parties sufficient time
26 to finalize the Settlement.

27 2. The new briefing schedule, if necessary, is as follows: The deadline for Appellants

1 to file their Opening Brief is **December 14, 2016**, the deadline for Appellee to file an Answering
2 Brief is **January 13, 2017**, and the deadline for Appellants to file a Reply Brief is **January 27,**
3 **2017.**
