

1 offer to settle it.³ The check was accompanied by a letter explicitly stating that Ocwen was
2 “authorized to deposit the check, provided that [Ocwen] do so with the understanding that it
3 constitutes payment in full. Your negotiation and depositing of the check, even if ‘under
4 protest,’ would constitute your acceptance of our offer.”⁴

5 Ocwen deposited the check, subtracted its amount from the balance, reported that the
6 account had been charged off, and continued to report that the remaining balance was due and
7 owing on the account.⁵ Bilderback disputed Ocwen’s reporting with the credit-reporting agencies
8 (TransUnion, Equifax, and Experian) because Ocwen was not reporting that the account was paid
9 in full as conditioned by the letter.⁶ Eventually, after Ocwen investigated the disputes, it deleted
10 the account from its report to TransUnion but continued to report the account—without any
11 mention of a settlement or subsequent disputes—to the other reporting agencies.⁷

12 Discussion

13 A. Motion-to-dismiss standard

14 Federal Rule of Civil Procedure 8 requires every complaint to contain “[a] short and plain
15 statement of the claim showing that the pleader is entitled to relief.”⁸ While Rule 8 does not
16 require detailed factual allegations, the properly pled claim must contain enough facts to “state a
17 claim to relief that is plausible on its face.”⁹ This “demands more than an unadorned, the-
18 defendant-unlawfully-harmed-me accusation”; the facts alleged must raise the claim “above the

1 speculative level.”¹⁰ In other words, a complaint must make direct or inferential allegations
2 about “all the material elements necessary to sustain recovery under *some* viable legal theory.”¹¹

3 District courts employ a two-step approach when evaluating a complaint’s sufficiency on
4 a Rule 12(b)(6) motion to dismiss. First, the court must accept as true all well-pled factual
5 allegations in the complaint, recognizing that legal conclusions are “not entitled to the
6 assumption of truth.”¹² Mere recitals of a claim’s elements, supported only by conclusory
7 statements, are insufficient.¹³ Second, the court must consider whether the well-pled factual
8 allegations state a plausible claim for relief.¹⁴ A claim is facially plausible when the complaint
9 alleges facts that allow the court to draw a reasonable inference that the defendant is liable for the
10 alleged misconduct.¹⁵ A complaint that does not permit the court to infer more than the mere
11 possibility of misconduct has “alleged—but not shown—that the pleader is entitled to relief,” and
12 it must be dismissed.¹⁶

13 **B. Ocwen’s report is not inaccurate under the FCRA.**

14 To state a claim under the FCRA, Bilderback must show that: “(1) [s]he found an
15 inaccuracy in [her] credit report; (2) [s]he notified a credit reporting agency; (3) the credit
16 reporting agency notified the furnisher of the information about the dispute; and (4) the furnisher
17 failed to investigate the inaccuracies or otherwise failed to comply with the requirements of 15

1 U.S.C. § 1681s-2(b)(1)(A)-(E).”¹⁷ The parties primarily disagree on whether the first and fourth
2 elements are satisfied, but because the fourth element is dependent on the first, I only thoroughly
3 discuss the first.

4 Bilderback claims that the credit report is inaccurate because she settled the account with
5 a valid accord and satisfaction. Ocwen disagrees and argues that the report is accurate because
6 the accord and satisfaction was ineffective, and the account truly was charged off as a loss.
7 Bilderback responds that Ocwen needs to report that she is disputing the charge-off label
8 (because, to her, it should say “paid in full for less than the full balance”); Ocwen counters that
9 the charge-off label is accurate, Bilderback’s dispute is therefore without merit, and the law does
10 not require it to report a meritless dispute.

11 Deciding this motion and the viability of Bilderback’s claims depends on the legal
12 significance of the check and accompanying letter. If Bilderback plausibly alleges that it
13 constituted an accord and satisfaction under Nevada contract law, then she also plausibly alleges
14 the “inaccuracy” element of her FRCA claim; otherwise her claim fails and must be dismissed.¹⁸

15 ***1. Bilderback has not pled a plausible accord and satisfaction.***

16 In Nevada, an accord is “an agreement whereby one of the parties undertakes to give or
17 perform, and the others to accept, in satisfaction of a claim, liquidated or in dispute, and arising
18 either from contract or from tort, something other than or different from what he is, or considers
19 himself, entitled to.”¹⁹ The party claiming that an accord and satisfaction was reached “must bear
20 the burden of proof and must establish *clearly* that there was a meeting of the minds of the
21 parties, accompanied by a sufficient consideration.”²⁰

1 a. *Insufficient consideration*

2 Ocwen argues that the check was insufficient consideration to support a valid accord and
3 satisfaction, and I agree. “Consideration is not adequate when it is a mere promise to perform
4 that which the promissor is already legally bound to do.”²¹ It is undisputed that Bilderback
5 legally owed the balance on the mortgage; the check and accompanying letter were an offer to
6 satisfy 10% of her legal obligation as if it were 100%. Ocwen received nothing out of the “deal”
7 that it was not already entitled to, so the accord and satisfaction fails for insufficient
8 consideration.

9 b. *No meeting of the minds*

10 The accord and satisfaction also fails for the additional reason that Bilderback has not
11 pled a meeting of the minds between Ocwen and herself. Even at this motion-to-dismiss
12 stage—where I accept all of the non-moving party’s allegations as true—it is clear that Ocwen
13 did not accept the accord and satisfaction despite the language in the letter.

14 The Nevada Supreme Court’s decision in *Pierce Lathing Co. v. ISEC, Inc.* illustrates the
15 point.²² Pierce was hired to paint and install moldings at Caesar’s Palace.²³ Because of
16 unforeseen circumstances, Pierce had to perform additional work that was not initially
17 contemplated by the parties.²⁴ Pierce submitted invoices for the extra work, and ISEC declined
18 to pay.²⁵ A couple weeks later, ISEC sent Pierce two checks totaling \$12,028.70 along with a
19 letter that stated, in relevant part: “Execution of this check will constitute full satisfaction of all
20 obligations owed by ISEC, Incorporated to Pierce Enterprises.”²⁶ Pierce deposited the checks

1 along with a disclaimer that said: “The above terms are not accepted by payee, payee claims extra
2 work in the amount of \$71,031.00.”²⁷ Pierce eventually filed suit against ISEC for the remainder
3 and raised essentially the same argument that Ocwen raises here: the accord and satisfaction was
4 ineffective—despite the language in ISEC’s letter—so ISEC was still liable.

5 The *Pierce* court then considered whether there was a meeting of the minds to support an
6 accord and satisfaction and analyzed two approaches. “In some jurisdictions, conduct revealing a
7 subjective intent not to accept the lower payment as full discharge of their claims is deemed
8 immaterial. The common law in these jurisdictions is that negotiation ‘under protest’ of a
9 conditionally tendered check constitutes an accord and satisfaction as a matter of law.”²⁸ Under
10 this approach, the creditor “can either accept the check on the debtor’s terms, or refrain from
11 negotiating the check and seek the entire disputed amount through the judicial process.”²⁹ The
12 *Pierce* court declined to follow this approach because it “would often result in unnecessary
13 punishment [to] the creditor. Specifically, it would disallow any creditor access to funds which
14 the debtor already concedes is owed because . . . even a disclaimer would not assist in preserving
15 the creditor’s right to litigate.”³⁰

16 The facts in this case, as alleged by Bilderback, clearly indicate that there was no meeting
17 of the minds between her and Ocwen. Although Ocwen did not include a disclaimer like Pierce
18 did when it deposited the check, Ocwen continued to report the account as charged off with a
19 balance still due and owing. Then, when Bilderback disputed the report, Ocwen verified that the
20 report was accurate. Based on these allegations, and applying Nevada’s subjective-intent
21 approach, I find that Bilderback has pled herself out of any inference that Ocwen agreed to an
22 accord and satisfaction.

1 c. *The other mortgage settlement and TransUnion report*

2 Bilderback alleges two facts to show that Ocwen’s report is inaccurate: (1) she settled an
3 account with a separate lender for 10% of the outstanding balance, and that lender reported the
4 account as “paid in full”;³¹ and (2) the account was deleted from her TransUnion credit report
5 after she demanded a reinvestigation following the results of her first dispute. Neither of these
6 facts show that Bilderback and Ocwen reached an accord and satisfaction—which would render
7 her credit report inaccurate—because neither fact shows that Ocwen received something that it
8 wasn’t already entitled to.

9 2. *The dispute was meritless and did not need to be reported.*

10 Next, Bilderback claims that Ocwen violated § 1681s-2(b) because it did not report that
11 she disputed the charge-off label on the mortgage, which made her report inaccurate or at least
12 incomplete to the point that it is misleading. But “a furnisher does not report ‘incomplete or
13 inaccurate’ information within the meaning of § 1681s-2(b) simply by failing to report a
14 meritless dispute, because reporting an actual debt without noting that it is disputed is unlikely to
15 be materially misleading.”³² “It is the failure to report a bona fide dispute, a dispute that could
16 materially alter how the reported debt is understood, that gives rise to a furnisher’s liability under
17 § 1681s-2(b).”³³ After receiving the notice of dispute from the credit-reporting agencies, Ocwen
18 verified that its reporting was accurate, so it did not report that Bilderback disputed some of the
19 information. As I discussed in section B(1), the parties did not reach an accord and satisfaction
20 under Nevada law, so Ocwen accurately continued to report the account as charged off with a
21 balance remaining. Any challenge to the charge-off label is, therefore, without merit. And
22 because meritless disputes do not need to be reported, Ocwen did not violate the FCRA by failing
23 to report Bilderback’s dispute. So I grant Ocwen’s motion to dismiss.

1 **C. Leave to amend would be futile.**

2 Rule 15(a)(2) of the Federal Rules of Civil Procedure directs that “[t]he court should
3 freely give leave [to amend a complaint] when justice so requires.”³⁴ The Ninth Circuit’s
4 amendment policy is generous; it requires a district court to grant leave to amend “even if no
5 request to amend the pleading was made, unless it determines that the pleading could not
6 possibly be cured by the allegation of other facts.”³⁵

7 It would be futile for me to grant Bilderback leave to amend her complaint. Bilderback’s
8 credit report would only be inaccurate under the FCRA if she and Ocwen entered into a valid
9 accord and satisfaction under Nevada law. The letter to Ocwen³⁶ tells me everything I need to
10 know: Bilderback offered to give Ocwen only a portion of what it was already entitled to.
11 Without completely changing the story, she cannot plead new facts that would allow me to infer
12 that the accord and satisfaction was supported by sufficient consideration. So my dismissal is
13 without leave to amend.

14 **D. Motion for leave to file supplemental authority**

15 Bilderback also moves for leave to file supplemental authority to support its argument
16 that Ocwen’s reporting is inaccurate because it fails to follow the industry standards outlined in
17 the Metro 2 guidelines—a standardized reporting format published by the Consumer Data
18 Industry Association. I need not address whether Ocwen must follow the Metro 2 guidelines
19 because I decide this case entirely on the basis that the parties did not come to an accord and
20 satisfaction. Because I decide the motion to dismiss on different grounds, I do not need
21 supplemental authority on the Metro 2 guidelines. Accordingly, I deny the motion because
22 considering the supplemental information would not affect this outcome.


1 **Conclusion**

2 Accordingly, with good cause appearing and no just reason to delay, IT IS HEREBY
3 ORDERED, ADJUDGED, and DECREED that Ocwen’s motion to dismiss [ECF No. 24] is
4 **GRANTED.**

5 IT IS FURTHER ORDERED that Bilderback’s motion for leave to file supplemental
6 authority [ECF No. 30] is **DENIED.** This action is **DISMISSED with prejudice and without**
7 **leave to amend.**

8 The **Clerk of Court is directed to enter judgment in Ocwen’s favor and CLOSE**
9 **THIS CASE.**
